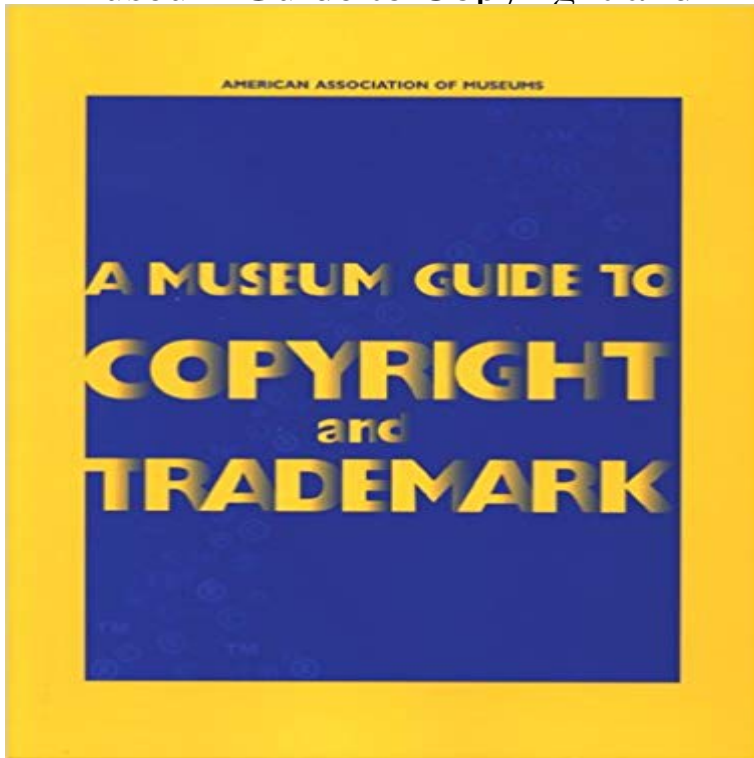


A Museum Guide to Copyright and Trademark
