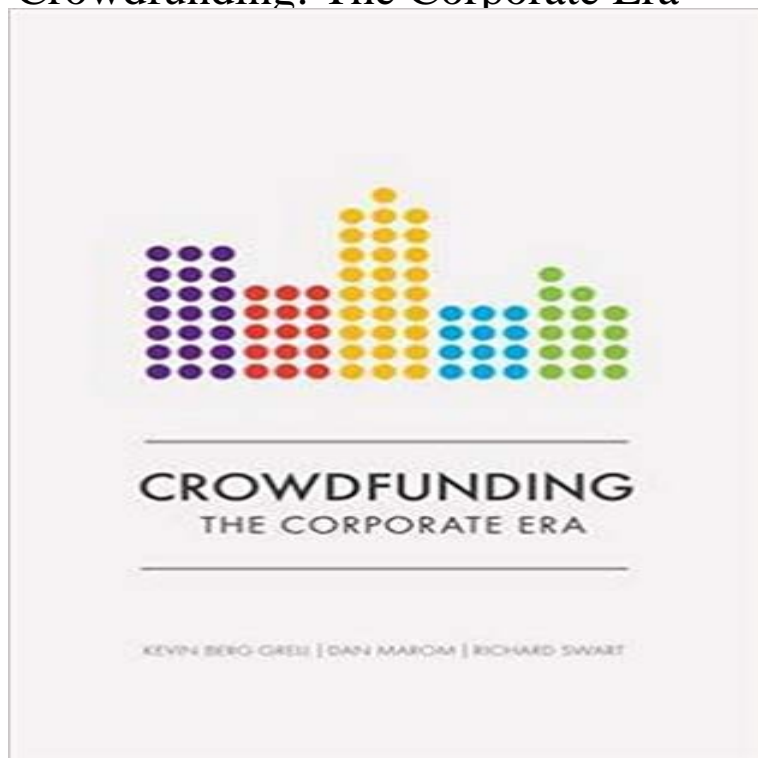


Crowdfunding: The Corporate Era
