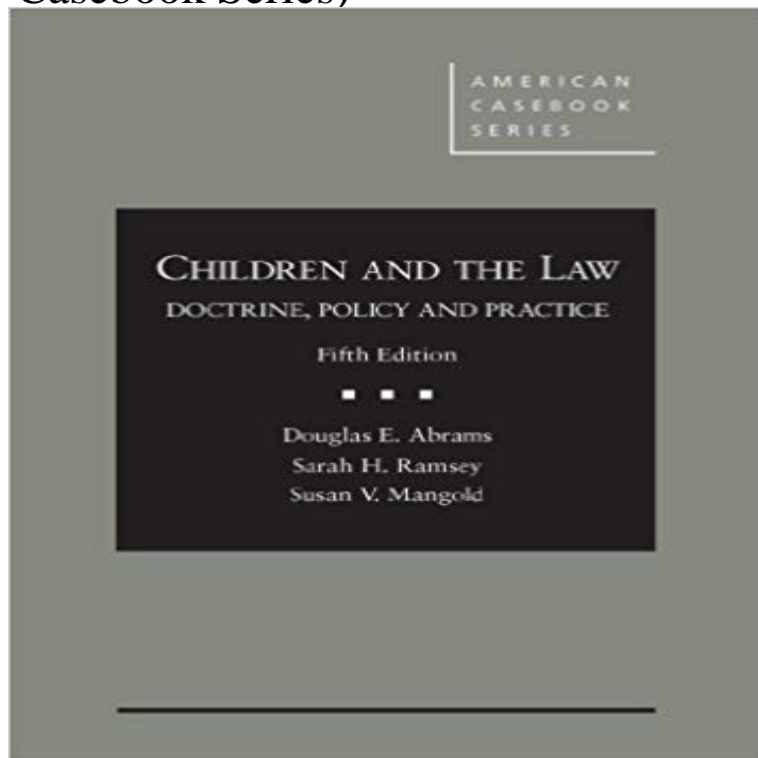


Children and The Law: Doctrine, Policy and Practice, 5th (American Casebook Series)
