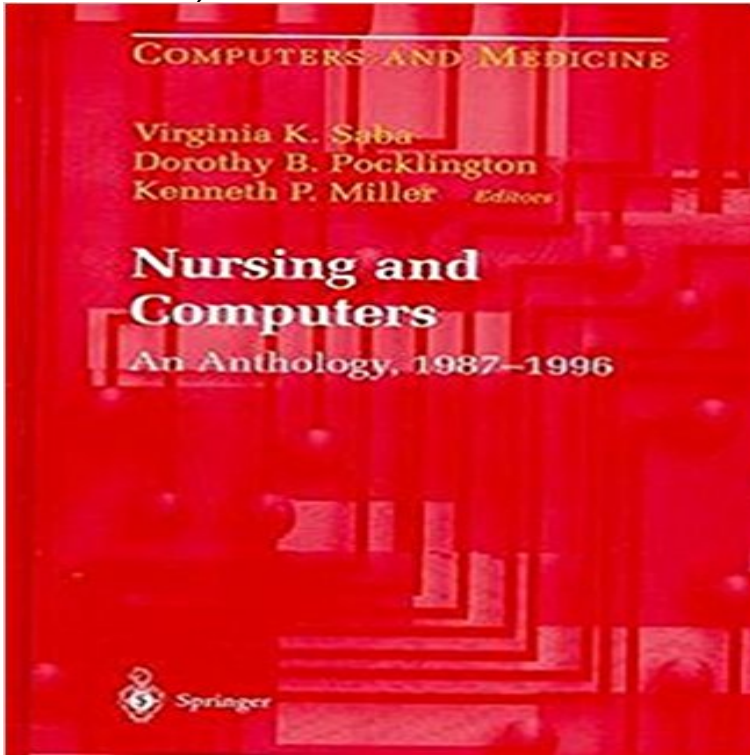


Nursing and Computers: An Anthology, 1987-1996 (Computers and Medicine)
