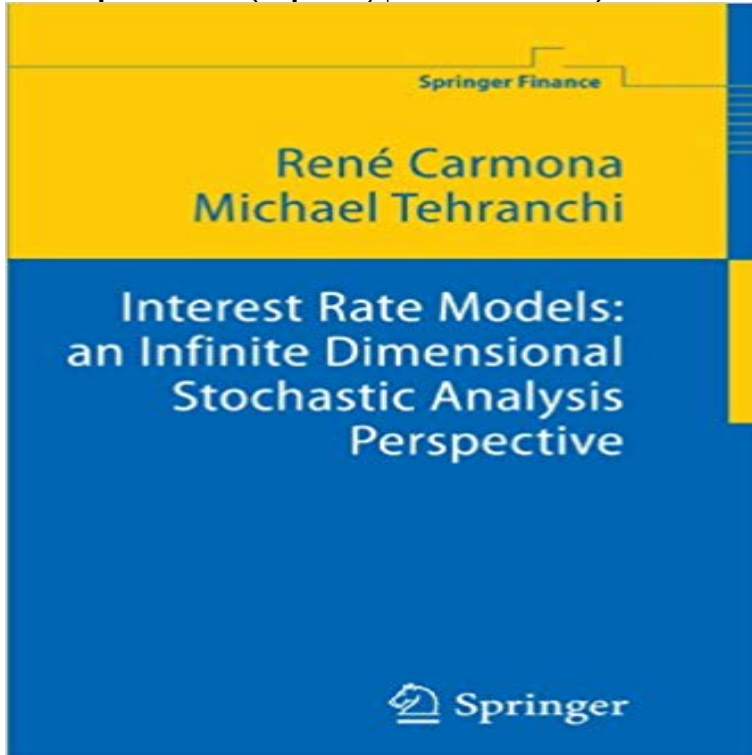


# Interest Rate Models: an Infinite Dimensional Stochastic Analysis Perspective (Springer Finance)
