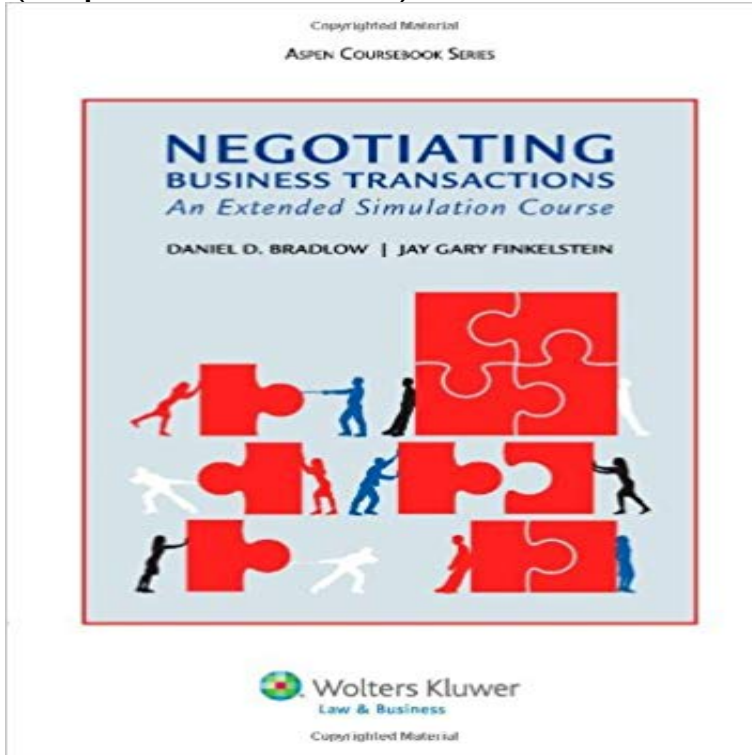


# Negotiating Business Transactions: An Extended Simulation Course (Aspen Coursebook)
