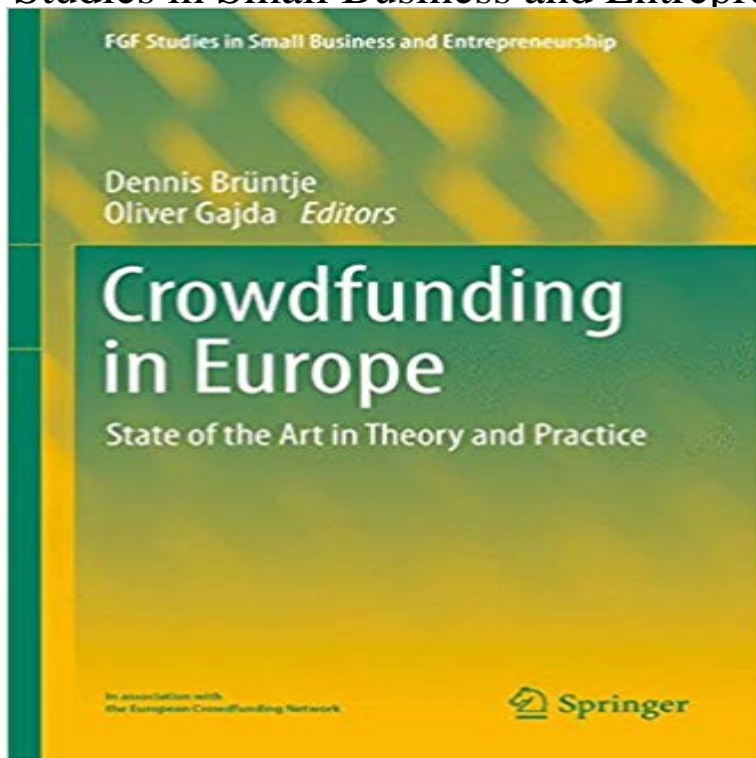


Crowdfunding in Europe: State of the Art in Theory and Practice (FGF Studies in Small Business and Entrepreneurship)
